General Comments

Licensing Staff arrived at the Facility to perform a Monitoring Inspection. Upon arrival, the 3's and 4's class were having quiet time. Some children were napping while others played quietly on their cots. Each room had soothing music playing in the background and a lamp that offered soft lighting. After 30 minutes, the children who did not want to rest, went to the tables for tabletop activities. In the 3's class, the Educators put out white boards with markers and building blocks. One Educator sat with the children at the table while the other Educator sanitized the cots before putting them away.

In the 4's class, the Educator sat with the children who were awake, coloring and playing with wooden puzzles. Once all the children were awake, the Educator read "Alligator Baby" to a small group while others built a train track. In the 3's class, the children had free play after quiet time. One Educator was seen reading to a group of children with others played with trains and an ABC shaped pasta sensory bin. In both classrooms, a timer went off, and the Educators put a clean-up song on. The children were observed helping the Educators clean before washing hands for afternoon snack.

The Afterschool room is large and inviting. There's a large area with Lego and Magnetic Blocks. There's a cozy space with books, blankets, pillows, and a cozy chair. The Educators greeted the children as they got off the bus. Once all children had arrived, they went inside to wash their hands for snack.

The classrooms and bathrooms are organized and clean. Cleaning supplies are locked with a key which is out of reach to the children. The Educators gave gentle reminders when needed and offered kind words and praise, "Good job, you did it!". The children's belongings were labelled, and the cubby area was tidy. Allergies are posted on the Parent Board and in each individual class. Artwork, family pictures and birthday walls were seen in each room. Licensing staff discussed with the Operator different ways they could add documentation in the rooms.
