General Comments

Annual Inspection performed.

Administrative records were reviewed - financials, incidents, staff and child attendance, fire drills, outdoor checklists etc. These records are neatly organized and stored securely and kept confidential. Child and Staff records are complete and in order. All staff are on target for completing 10 plus hours of PL training and they continue to enroll in PL sessions. The operator is planning to offer some of her own PL training this year. Potential illness forms are completed and parents are picking up children within the hour, illness notices are posted, medication records are documented, incident reports are being signed off so parents are made aware. All children were observed in the outdoor play space. Educators had set up a bubble machine and playing music in the background. Children were loving this and were seen dancing and trying to catch the bubbles with their hands. Lots of toys, equipment and materials were observed outside and also indoors in the individual classrooms. Ample shade was provided - more than 10%. There are places for children to sit, soft pillows available in the screened shaded area, places to be active - climbing on the dome, sliding, running. Children were having fun playing on the tires and testing their limits through risk taking. Some children were seen playing in the sand area in small groups. Appropriate transitioning between activities. Transitions are kept to a minimum educators provide gentle reminders and children given ample time to wind down for after lunch nap. Classrooms are inviting and organized to provide children are variety of opportunities for them to explore and create and accommodate children's emerging interests.

Lots of playful conversation and interaction between educators and children. Spring and bugs and flowers seem to be the topics of interest with the children. They are learning about different types of bugs, parts to a flower and a webbing activity was posted on what Spring means to the children. Lots of visual images observed with the printed word which is a great introduction to language.

The school age group after eating lunch got ready for outdoor play. Educators sent reminders home to parents to send sunscreen and hats. Educators were observed assisting the younger children with applying the sunscreen and taking out water bottles for outdoor play.

This facility is well operated and is recommended for licensing.
