General Comments							
Monitoring inspection completed. No compliances to address. This is a first week back after the holidays for many children. Most children are managing with the change from their routine since being home over Christmas. Administrative records were reviewed, and attendance of staff and children is being tracked daily, fire drills and outdoor maintenance check list is completed monthly, cleaning of toys, equipment and materials is evident. Awesome evacuation times observed on fire drills check list. No illnesses to report during this visit. Staff information was reviewed, and this is all in order and up to date. Currently all FT staff have completed or about to complete their ECE training program or have the 90-hour Intro to ECE completed. This is great news! No turnover in staff from my last visit and more than enough educators on site to meet and maintain ratios during breaks and lunches. This enhances the quality of the service offered at this facility. Today, children were observed eating snack, using a variety of loose parts to make interesting creations and holding it all together with glue. Other children were building with lego and helping each other put a snowman puzzle together. The 4's were learning the concepts of equal, more, less, same and playing a memory game. They really enjoyed this game and it was obvious they have played it before. It was all about matching numbers and they practice their numbers daily when filling in the wall calendar. Staff were observed giving children choices in activities, engaged in play and assisting with materials. Children were observed singing, listening to stories and observed engaged and sitting with children and interacting with them at their eye level; and observed in playful conversation. Children's attwork was made to feel important as it was posted in the classroom. Children were also observed going down for nap. All children are provided with a cot and blanket, though children who do not nap are given opportunities to play quietly while their friends rest. No
