Comments: During today's Monitoring Inspection, Licensing Staff noticed in the 2's classroom the children's napping items such as blankets and pillows were touching one another. A conversation was had with the Operator about ensuring the children's belongings are being stored separately.   Operator separated the children's napping items immediately. Deficiency is now compliant								
General Comments								
Licensing Staff arrived at the facility to perform a Monitoring Inspection. Upon arrival, all classes were observed having free play. Children were seen building with Lego, reading books, coloring and making meals in the play kitchen area. Classrooms and the washrooms are clean. Each classroom has a variety of current learning stories, age-appropriate artwork displayed and pictures of the children throughout.								
Hand washing was observed before the classes gathered for morning snack. The children's lunchboxes and water bottles are labelled and stored separately. In the 3's classroom, they were celebrating a birthday today. The children gathered with the Educator after snack and sang Happy Birthday to their peer. The children were excited to celebrate with their peer by having a dance party with music and a disco ball. The children were observed laughing, smiling and dancing with one another.								
Only positive child guidance was observed. The Educators were actively engaged with the children, sitting on the carpet reading with them, dancing together and sitting at the table with them during snack. Educators were seen offering hugs and asking children for permission before wiping faces after snack time. Staff and child profiles were reviewed today. All files were easily accessed and organized.
