Comments: This is a second reminder that in 1 child record, the name, address, and telephone number of a medical practitioner was missing. The operator contacted the mother via text message while the Quality Assurance Monitor was on site to ask if they have a medical practitioner. The operator can send a picture via email of the child record completed to the Quality Assurance Monitor.			
31(3) An operator shall maintain the outdoor play area of a licensed facility to ensure the safety of the children.	31(3)	Dec 04, 2023	
Comments: This is a second reminder that the outdoor area must be maintained safe and free of hazard. The Quality Assurance Monitor observed that the metal bed frame at the outdoor of the entrance has not been removed. The metal bed frame must be removed to keep the outdoor area safe and free of hazard. A picture of the metal bed frame removed from the entrance can be sent to the Quality Assurance Monitor via email.			
39(2) A licensed facility shall have a separate locked storage space that is inaccessible to the children for each of the following: (a) toxic products, chemical products and cleaning supplies;	39(2)(a)	Dec 01, 2023	Dec 15, 2023
Comments: The Quality Assurance Monitor was able to observe that all toxic products, chemical products and cleaning supply are locked and inaccessible to children. Deficiency is now compliant.			
39(2) A licensed facility shall have a separate locked storage space that is inaccessible to the children for each of the following: (b) medications.	39(2)(b)	Dec 01, 2023	Dec 15, 2023
Comments: The Quality Assurance Monitor was able to observe that all medications were locked and inaccessible to children. Deficiency is now compliant.
