Comments: The inspector observed that the fire extinguishers are not labelled with the expiry date. The operator must ensure that the fire extinguishers are inspected every year.			
31(3) An operator shall maintain the outdoor play area of a licensed facility to ensure the safety of the children.	31(3)	May 30, 2025	
Comments: The inspector observed that the wooden fence is showing damage, and some nails are sticking out. The operator must ensure that the wooden fence is fixed to ensure the safety of the children.			

General Comments
<p>The inspector is on site to conduct the renewal inspection. During the visit, the inspector observed the children engaging in free play with the operator, as well as during lunch and nap time.</p> <p>The operator must ensure that the protective surfacing beneath the slide meets the required depth for safety.</p> <p>The operator stated that she did not have to fill out management of potential illness form, incident log, and a notice to inform parents of the existence of a communicable disease at the facility in the past year. She stated that she did not give any medication to children in the past year.</p> <p>The inspector and operator had a discussion regarding her new facility.</p> <p>The ratio is respected during the inspection.</p>
