This morning, they were going to Barkers Point Elementary School for "Reading Buddies". The operator set up the car seats and the children got settled in the van.</p> <p>Once they arrived at the school, they went inside together and made their way to the classroom. The children got their jackets and boots off and met with the students. The students had prepared various activities to do with the children. Each child had a student to be paired up with. The students had brought out colouring materials, books, playdoh, and mini hockey sticks. Most of the children played with playdoh and one child coloured. The students were sitting with the children and engaging with them. Some children started playing mini hockey.</p> <p>The children then cleaned up and sat at the table. The children were asked to draw, and their reading buddy would help them write a sentence of what they would like to do next week. The children then played with blocks, making shapes and towers. The children started cleaning up and getting ready to leave. The children and students said goodbye to each other. The operator got the children settled in the van and returned home for lunch. Lunch today was shepherd's pie.</p> <p>The operator is attentive to the children and speaks kindly to them. The home is decorated with pictures of the children and their artwork. Learning stories are posted along with recent activities. Only positive child guidance was observed.</p>
