<p>Monitoring Inspection - COVID-19 Recovery Phase:</p> <p>Children engaged in both outdoor and indoor play this morning.</p> <p>It is evident staff have been frequently cleaning the learning environments, high touch areas, washrooms and toys. A cleaning schedule has been created and is implemented well.</p> <p>Hand washing routines observed when children arrived back from outdoor play.</p> <p>Positive interactions between the educator and children were observed during transitions and washroom routines.</p> <p>Group Logs must be kept on Appendix C. This log should include all children in the established group every day. The date established only changes if a child or staff member is added or removed from the group log.</p>
