<p>General Comments</p> <p>A renewal inspection occurred today.</p> <p>The children were observed reading stories with their educators, building forts, playing with playdough, and coloring pictures. All classrooms were observed going outside. While outside the children were observed playing in the snow, sliding down the slide, riding in cars, making snowballs, and playing hide-and-seek.</p> <p>The classrooms were set up with age-appropriate toys and materials. The educators were observed engaging in play and conversations with the children. The documentation around the center was current and reflected the New Brunswick Curriculum Framework.</p> <p>Diaper changing and hand washing procedures were observed.</p> <p>Transitions from the classroom to the washroom ran smoothly. The educator brought a basket of quiet materials for the children to use while waiting their turn to use the washroom.</p> <p>The following records were reviewed: Incident logs, fire drills, playground checks, daily attendance sheets, and infant toddler daily sheets.</p> <p>All staff files were viewed, and a random review of child files was completed.</p>
