## **General Comments**

A Monitoring Inspection occurred July 16, 2025.

The children were observed participating in a variety of indoor activities, having snack, and transitioning outdoors. Some groups went for a walk, while others headed to the playground.

Infant Room: The children were on an outing in the community. Upon their return, the transition from outdoors to indoors was observed. The children proceeded to the indoor classroom to get ready for lunch. Educators noted that the children are currently interested in messy play.

## **General Comments**

Toddler Room: The children were observed eating snack, with educators sitting alongside them and actively engaging in conversation. Following snack, the children participated in an open-ended art invitation that included materials such as paint, paintbrushes, straws, sticks, paper, and foil pieces. Educators indicated the children are currently showing interest in cars, dinosaurs, flowers, animals and baby dolls.

Three-Year-Old Room: The children were observed engaging in a story with their educator, using animal puppets. The educator indicated that the children are currently interested in scooping, pouring, dumping, dump trucks, bugs, and water play.

Preschool Room: The children were observed eating snack, engaging in free play, and getting ready to head to the playground. The educators applied sunscreen, offered gentle reminders to wear hats, and filled the children's water bottles before they went on their outing. The educators indicated the children are currently interested in nature, bugs, and water play.

Several forms of documentation were visible throughout the facility, including individual art portfolios, learning stories, learning webs, photographs, and children's artwork. The rooms were well-organized and inviting, offering a varied supply of age-appropriate materials, books, and toys. A clearly visible and prominent area was designated for posting the facility license, current monitoring reports, and any orders for compliance.

A conversation took place with the Administrator on the following:

Ensuring all staff are well-informed of any children in the facility who have medical conditions or allergies.

Administrator to refer to Appendix B of the Guidelines for the Prevention and Control of Communicable Diseases in Early Learning and Childcare (ELC) Facilities - the New Brunswick Guide for Exclusion of Children in Early Learning and Childcare Facilities, to ensure that Potential Illness Forms and Return After Exclusion forms are completed when applicable.
