| <p>- Child to staff ratio was respected during the renewal inspection.</p> <p>- A follow-up will be made to receive proof that all eligible employees have completed their required professional learning hours before October 31st.</p> <p>Discussions:</p> <ul style="list-style-type: none"> <li>- The administrator confirms that the slide in the preschool play area is installed according to the CSA standards.</li> <li>- Administrator will put a plan in place to ensure that the outdoor play area is verified regularly for any items that could affect the safety of the children.</li> </ul> <p>Observations:</p> <ul style="list-style-type: none"> <li>- Infants did free play and educators were sitting on the floor with them. Some were interested in farm animals, pop its, vehicles and more.</li> <li>- The two-year-olds were doing free play and then went outside.</li> <li>- The three-year-olds were painting a house drawing with the colour of their choice.</li> <li>- The four-year-olds talked about the date, colours and numbers.
