General Comments

- Visit completed at the establishment in the morning for a monitoring inspection.
- During the visit, ratio was respected. Infants are only mixed with preschool age children outside the hours of 8:30 am to 4:30pm
- The personal files contain all required documentation. Administrator and educators have completed the Introduction to ECE course. All 18 employee files were verified during the visit.
- Personal belongings are labelled with the child's name. Easily accessible and stored separately for each child. Pacifiers or soothers do not have neck strings. Infants who cannot hold a bottle are held during feeding. Infants are not bottle fed while laying down. Infants are always supervised when eating or drinking. Drinking water is provided throughout the day.
- Toxic products, chemical products and cleaning supplies are locked and inaccessible to children.
- Individual space is provided for diapers, creams and wipes for each child who is not toilet-trained. Changing area is located one metre or less from a sink. Diaper changing procedures are posted in a visible place in the diaper changing area. Diaper changing station is located in the infant room and in the washroom. Children are always supervised during diaper changing.
- Daily information sheets are completed for each child under 24 months.
- Observations:

Infant room:
During the visit, two children had a nap, participated in free-play activities, ate their lunch provided by the parent, and had another nap. During free play, the educators were sitting on the floor singing with the children and engaging in their play.

2-3-year-old room:
The children came in from outside, washed their hands, and had their lunch provided by the parents

3-year-old room:
During the visit, diaper changing was observed.

4-5-year-old room:
The children came in from outside, washed their hands, and ate their lunch provided by the parent. Parent arrival was witnessed.

During the visit, the preschool children went outside to play. The educators were engaged in the children's play and were interacting with them. The children were constructing with wooden blocks, playing with trucks, the

kitchenette, and on the play structures.

- Discussion with the educators on nutrition and personal belongings. The educators advised that drinking water is provided to the children throughout the day.
