<b>General Comments</b>  A renewal inspection occurred today. The children were observed during indoor free play, outside play, lunch and quiet/nap time. Each of the learning environments have the children's current interests displayed in the form of webs, art and learning stories. Children's portfolios are in each of the rooms with evidence of the children learning and samples of their art creations. Discussed with every educator present during inspection the requirements for Designation for professional learning hours for educators with their ECE or equivalent or their 90-hours of training. Clarification to follow regarding the numbers of professional hours that educators can accumulate per year using webinars. Educators were observed sitting with the children during lunch having conversations with them. They were also observed having positive interactions on the playground and inside their respective learning environments.
