Comments: During the time of inspection it was noted that there are no step stools or platform available to the children within the washroom(middle school washroom) that is used for hand washing upon arrival to the program. The children are not able to reach the soap dispenser independently. A platform or step stools are to be								
added to this washroom.								
General Comments								
The renewal inspection was completed today. Hand washing and snack time routines were observed. The educators had purposefully planned invitations set up and ready for the children prior to their arrival. New sensory materials have been added to the sensory bins today and this week for the children to explore. The educators were observed interacting with the children at their level, eating snack with the children, and listening intently to their stories they were sharing. The children engaged in conversations with their educators and made predictions about the materials within their environment. The program routine was flexible to allow for children to partake in snack when they wished. New materials have also been added to the dramatic play area this week, and the children were observed exploring this area as a new interest. Materials within the environment are set up in an organized, and inviting way. Books have been strategically placed throughout the room to promote literacy. Discussed outdoor play with educators today. The playground is closed during the winter months, and during this time the children use the field close by. There was evidence of potential illness forms being completed as required.
