## **General Comments**

Monitoring Inspection- COVID 19 recovery Phase.

Upon arrival family member/ guardian is signing in and taking temperature to meet requirement for entering the building. Ensure thermometers and pens being used are being sanitized between users. Staff are confirming children have been screened for wellness and checking off on group log.

Requirements with regards to additional cleaning observed during monitoring inspection as one staff was busy ensuring cleaning was being completed.

Discussed Group Logs with on-site manager . Date group established to be recorded each day as the date the group "bubble" was formed and not the current date. Date established will only change when a new child who was not previously in attendance starts.

Also discussed outdoor play area. Outdoor play area can be divided to accommodate 2 groups at one time as long as 2 m distancing is created between groups.

For staff member (maintenance) who would be entering rooms on multiple licenses throughout the day, a community mask should be worn.

Preschool children observed in play. Children were drawing, reading books, and playing in the dramatic play area. Educators observed engaged with children.

School-age children were preparing to head out for a walk.

Throughout all learning environments, documentary evidence of children's learning posted inside and outside of rooms.

General Comments

In room 15- recommendation to ensure books are neatly displayed and easily accessible.
