Comments: Room 14 Washroom is under renovation, door was unlocked and tools and debris from construction on the shelves and floors. This is to be locked at all times. Maintenance is working on the renovations after operating hours. Discussed with Educators to ensure the washroom is locked while the children are present. Children currently utilizing washrooms facilities in the hallway adjacent to their learning environment. Lock installed during inspection. Deficiency is now compliant.							

General Comments

A renewal inspection occurred today. The children were observed during inside play, going on a walk, outside play, lunch and playing in the breakout room, which has been created in the "cafe room". This area has sensory activities set up for smaller groups of children to have a change from their normal learning environment. This is shared between Rooms 14 and 15. Children are supervised at all times with an Educator in this room. In Room 14 the children are learning about sea animals and during the inspection they did an experiment and learned how octopus protect themselves from predators using their ink as camouflage. The learning is documented and displayed throughout the room. Discussed adding to the "hut area" books regarding what the children's current interests are. Also discussed adding dolls to this room as the girls have an interest in babies/dolls. Discussed ensuring that both Room 14 and 15 have access to dolls if there is an interest in both rooms.

In Room 15, the children are learning about different modes of transportation and the documentation on the wall

supports this, depicting the children making their own vehicles from cardboard boxes and art supplies. The School-Age Room, the children's learning is documented and displayed in the walls. Showing past activities including a PJ Day, Bowling Day, and walks to neighboring Rockwood Park. In the learning environment there is an authentic tea set including China tea pots, cups and dishes. The Reading corners is set up with cozy chairs and age-appropriate books. Learning centres in this room were set up prior to the children arriving from school. In Room 15 licensing is recommending installing blinds/curtains as the room becomes very warm. It receives the direct sunlight in through the windows for the majority of the day.

Educators in all rooms were observed speaking kindly to the children, redirecting behaviors appropriately and down at the level of the children in their play and learning.
