They are presently interested in animals.</li> <li>-Older infants were participating in a group painting activity. They were painting a large cardboard box which they are going to make into a boat. They are presently working on "things that go".</li> <li>-2/3 year old room were getting ready for nap during my visit. Their interests are moving, jumping and climbing.</li> <li>-2/3 year old room were napping during my visit. This group enjoys risky play and testing limits and are working on making safe choices.</li> <li>-3 year old room were playing outside upon my arrival and were having lunch/story time during my visit. This age group is interested in letters and telling time, amongst many other things.</li> <li>-Observations, planning and documentation are visible in every room.</li> </ul> <p>-The facility meets licensing requirements under the Act and regulations.
