General Comments

- -Unannounced monitoring inspection at facility
- -Ratio was respected during the visit.
- -More than 50% of staff have their certificate in Early childhood. One staff is into her 90 hours at the moment.
- -Children are supervised at all times when using the washroom, the center has the proper number of functioning and available toilets and sinks, potty chair or training seat is provided for children being toilet trained.
- -Toxic products, chemical products and cleaning supplies are locked and inaccessible to children.
- -Easily accessible space is provided for personal belonging, the space is labeled with the name of the child. Pacifiers or soothers do not have neck strings.
- -Parents are required to notify the operator when their child is absence is due to illness or another reason.
- -Children who become ill are supervised and separated from the other children, parents must pick up the child within the hour.
- -No trampoline is being used at the center.
- -There was no hot beverage in areas occupied by children.
- -The first aid kit has all the required items and is accessible on the premises.
- -Discussion with the operator in regards of designations, professional learning hours and parent committee.

Observations: When arriving at the center, the junior toddlers were having snacks and the babies were just finishing snacks they then got ready to go outside. Both 2-year-old group was outside, when coming in one group went into dizzy play and the other group were doing construction. The tree year-old group was just finishing snacks and getting ready to go outside. During the visit I could ear a lot of signing and rhymes. Webbing and documentation are into each classroom and hallways.
