- -Posted in a visible and prominent place in the facility are the following documents: The license, inspection report, orders for compliance, daily routine, evacuation procedures, name of administrator, name and telephone number of QA Monitor and Inspector Life-threatening allergies and a notice to inform parents of the existence of a communicable disease.
- -Children's guidance is done in a respectful and positive way
- -Infants are supervised at all times when eating or drinking
- -Infant bottles are stored with a cover in the refrigerator, labeled with the child's name and only used for the intended child
- -Allergy information on any child is posted in the food preparation area
- -Drinking water is provided throughout the day
- -Food brought from home is labeled with the child's name and refrigerated or has an ice pack as required
- -A first-aid kit and a phone are always accessible on site and on outings.
- -During the visit, no hot beverage was found in the children's indoor and outdoor play area
- -One new employee did not have her criminal check into her file, she left the center to get it done and will reenter the center once she has her check done. A copy will be sent to licensing staff by e-mail.
- The daily activities inspection checklist was given to all educators; we discuss on how they apply items and which item needs to be increased in their room.

Observations: When arriving at the center all children were playing outside, they came washed their hands and got ready for lunch. Once lunch was done, they all got ready for nap time.
