General Comments

- Morning visit to the establishment for an unexpected monitoring inspection
- During the visit ratio was respected in a mixed age group and a same age group
- Review and discussion of the incident report form. It was discussed with the operator and the director the list of incidents that are considered reportable
- Daily incident log is maintained, and signed by the parent
- Incident reports are maintained in the child's file
- During the visit, it was observed that all educators are engaged with children at their level providing support and having conversations.
- It was observed during the visit that when in a situation of misunderstanding, children's guidance is done by listening to both parties guidance is provided towards problem solving to allow children to find a solution together.
- Allergy information on any child is posted in the food preparation area
- Drinking water is provided throughout the day
- Infant bottles are stored with a cover in the refrigerator, labeled with the child's name and only used for the intended child
- Food brought from home is labeled with the child's name and refrigerated or has an ice pack as required
- In the outdoor play area children have more than one type of surfacing to play and explore, the material offered is varied and in sufficient quantity for children present
- Outdoor play area is maintained safe
- The outdoor play area has the amount of shade needed for each child based on the maximum number of children that can be accommodated in the outdoor play area
- In all rooms, evidence of purposeful planning based on children's interest and learning was seen, there was webbing, photos and calendar showing incoming activities and learning stories were posted.

Observations: When arriving at the center, the two-years-old were going on an adventure in the neighborhood, when arriving back they all had picked flowers. The infants were playing outside in their fenced in space, there was a lot of water plays and sand box play involved. Some of the three's and four's went for a walk while another group of three's played outside in the sand box and explore their surroundings.
