General Comments

- -Mid-day visit to the establishment for an unexpected monitoring inspection
- -Ratio was respected during the visit
- -The daily information sheet for infants (0-24 months information about the child's mood, eating schedule, rest time, diaper changing) is completed every day and stored in a file that is kept in the office at the end of the week
- -New staff records contain required checks and documentation
- -Medication are locked in a cabinet in the kitchen, it is inaccessible to children
- -Medication used for anaphylactic shock (EPIPEN) are stored safely (inaccessible to children) but easy to access for staff
- -Educators were seen, facilitate children's learning by engaging in play and asking open-end questions.
- -Portfolio which highlights children's learning and development are easily accessible (on top of the children's cubbies)
- -In all rooms, evidence of purposeful planning based on children's interest and learning, webbing, invitation, photos and learning stories were posted.
- -Each napping child has a cot that is appropriate for their height and is in good repair
- -Staff confirms that all bedding material is washed weekly them and the parents. Sheets are washed by the staff and blankets are sent home to be washed by the parents
- -Diaper changing station is found in the washroom between the two infants' room, and in the basement, diaper changing is done in the two-year-old room and the washroom between the two's and three's. Individual space is provided for diapers and changing necessities. The changing table is equipped with a safety strap and covered with a non-absorbent layer, it is separated from the food preparation and is located one meter or less from a sink and children are always supervised during diaper changing.
- -Diaper changing station is located one meter or less from a sink

Observations: When arriving at the center, children were all getting ready for lunch. Hands were washed, diapers were changed, and everybody went to sleep.
