During the renewal inspection, inspector observed indoor play, outdoor play, the lunch period as well as the rest period. Inspector observed positive interactions between the Operator and the children, such as getting on the children's level to interact with them as well as gentle reminders. Operator was seen reading stories to the children. Inspector observed children washing their hands before and after lunch as well as the Operator providing fresh water to the children after coming inside after outdoor play. The children are learning about caterpillars and appear to be interested in this topic. Operator must ensure that a garbage can with a lid is added to the washroom for used diapers. Ratio was respected during the inspection.
