Comments: Please ensure that all toxic products are locked at all times. There was toilet cleaner above the sink in the 3's room and the cabinet containing toxic products in the 4 year old room was unlocked. The laundry room must also be locked at all times.			

<p>General Comments</p> <p>The environment at Angie's Little Peeps is very relaxed and engaging. Educators made the children their first priority in each classroom visited and were seen interacting with them at their level by playing and speaking to them. Child guidance was direct and positive at all times.</p> <p>Throughout the facility and the classroom, licensing staff observed learning stories, pictures, collages, family pictures, artwork, and portfolios. The examples of programming and documentation were visible to both adults and children. The learning centres were clearly defined and supported with facts and educational resources. Educators have seized moments from the children to make learning fun and interesting. There is a good balance</p>

All toxics must be under lock and key at all times.

All staffs criminal record, vulnerable sector and social development checks should be redone prior to the five year expiry date.

Fire drills must be conducted monthly. The operator stated that she has passed on the responsibility to an educator as they have not been completed consistently.

Once the compliances have been met I will be able to recommend facility for licensing.
