General Comments

Licensing staff arrived at the facility at 9am for a monitoring inspection. Upon arriving the children in all classrooms were observed eating their morning snacks. The educators were observed supervising the children while they ate. After morning snack, the children were observed washing their hands before engaging in free play activities. Such as playing with Legos, sensory bins, reading books and on the indoor climbing structure. Licensing staff recommends adding more protective surfacing in the "mixed" classroom under the wooden climbing structure.

Later, a verbal prompt was given to the 4/5 classroom to start cleaning up and get ready to go outside for graduation pictures. The children were prompted to change their shoes and gather their jackets before going outside. A head count was completed at each transition area to ensure that all children were present. Water bottles and first aid bags were brought outside with the children. The 4/5's classroom were observed sitting on logs in the outdoor classroom with educators. One by one, the children got their graduation pictures taken by an educator. After, the children engaged in activities outside. The children played with mud kitchen accessories, balls, on the slide, in the woods in the dramatic playhouses and on the balance beams.

The infants were observed playing at the top playground and were not mixed with the pre-schooled aged children while outside. The infants were observed playing with a milk water and flower sensory bin, riding on tricycles, and with mud kitchen accessories. The educators were actively engaged in the children's activities and were heard asking the children open ended questions while engaging in play. The children were supervised at all times while playing outside. Washroom breaks were done while outside. When an educator headed inside with a group, they communicated how many children they had with them to the other educators. Frequent head counts were completed while outside.

A verbal prompt was given to the children to start cleaning up before going inside for lunch. Once inside, the children changed their shoes and washed their hands, free play occurred before lunch. One classroom was observed engaging in a group "food chain activity" the educators were heard asking open ended questions to the children during this time. Hot lunch arrived at 11:50pm. The children were observed washing their hands before finding their place mats at the tables. The educators were observed serving lunch to the children while

supervising them.

The indoor environment was clean and well organized. The children's personal belongings were well stored and labelled. The necessary information was posted at the entrance. Child artifacts, learning stories with ties to the curriculum and infant daily information sheets were completed. Daily attendance was taken in each classroom. Various and sufficient indoor and outdoor play materials were present on the day of the inspection.
