General Comments

Upon Licensing staff arrival, the children were playing in stations throughout the gym. Children were observed making a craft, using Lego, playing with Barbies, using a car mat with animals and cars, playing Uno and using doodle boards. Educators were observed playing with the children and were actively engaging in conversation. When the children rotated stations, the transition between activities were smooth as the children were given plenty of time ahead and there was evidence of a daily routine. Educators used directives that engaged the children's attention such as "Hands on top. Everybody stops." and "1,2,3... Eyes on me."

Before snack, the tables were cleaned, and children lined up to wash their hands. Gentle reminders were heard on using kind language with friends and waiting for their turn in the washroom. For snack, the children sat together at the tables and had pancakes with sirop, cheerios and apple sauce. After snack, Educators were observed promoting independence and asking the children to clean up their snack space. The tables were again cleaned, the floor was swept, and the group got ready to go outdoors to play. Water bottles, the first aid pack and attendance were brought outside, the staff were observed conducting frequent head counts and using walkie-talkies for easy communication. Once outdoors, Educators split to maintain a clear line of stie and children were observed playing on the play structures, sitting together on the tree stumps, and using shade play material that was brought outside such as trucks, bubbles and play animals. Frequent water breaks were observed as the weather was sunny and hot.

During inspection, child and staff files were verified and the parent board contained all required documentation. Allergies, the daily snack menu, emergency evacuation plan and the daily routine were visibly posted. Monthly fire drills are being conducted as well as playground maintenance checks and first aid kit checklists are being maintained.

Licensing staff recommends for renewal.
