Comments: When conducting the license renewal inspection, licensing staff noted that the cleaning supplies were located in the laundry room and secured by a chain that is out of the children's reach however, all cleaning supplies and toxic materials are required to be locked in a cabinet, closet or room that is secured by a lock and key.							
General Comments							
Licensing staff arrived at the licensed facility on September 27, 2021.							
Children had not yet arrived at the licensed facility upon arrival. The operator met the children at the bus stop once the bus before the bus arrived.							
The children washed their hands when they arrived and proceeded to have their snack. After snack the children engaged in free play until they went outside.							
The operator is very kind and has a very good demeanor with the children. She interacts with the children at their level.							
Please ensure all cleaning supplies and toxic materials are secured in a cabinet, closet or door that requires a lock and key to open it in order to maintain the safety of the children.							

Please replenish the protective surfacing surrounding the stationary equipment located in the outdoor play space to measure the recommended depth by the manufacturer's manual or by the Canada Consumer Product Safety Act.
