<p>General Comments</p> <p>On the morning of the monitoring inspection, children were engaged in many activities. The educators had planned an extensive "Ocean Week" and invitations, books, postings and materials supported this. The book area had a collection of both fiction and non-fiction books. Sensory activities with colored water, sand, droppers, shells and realistic animal figures were set out on trays. Acrylic and water-colored paints were available for children to choose from.</p> <p>Throughout the morning, open snack was offered, and children could freely move around the rooms choosing activities.</p> <p>Educators were attentive to the children's needs, offered support, celebrated accomplishments with the children while also allowing for independence with new skills.</p> <p>An educator shared that children have enjoyed finding insects in the outdoor play space. She had set up a habitat with a pupa. Other resources were added to set up an invitation for the children- a magnifying glass, books, and images showing the life cycle of the moth.</p> <p>During outdoor play, children had access to many materials- balance bikes with helmets, scoops, shovels, balls and places for climbing and balancing.</p>
