The administrator contacts the other facility and gets an updated copy to put in their staff files. Deficiency is now compliant.

The QAM had a discussion with the administrator to transmit the information to the parents in order for them to bring a new EpiPen on site Monday.</p> <p>During the renewal inspection, the QAM observed the children playing in the outdoor play area. The QAM also observed the children transitioning to the indoor play area, children were observed playing with toys brought from home. Children were also observed playing to pretend family play, creating their own hungry caterpillars and transitioning to lunch time. Pizza was served for lunch today with vegetables and milk. The children were also observed transitioning to nap time.</p> <p>Positive interactions were observed between the educators and the children.</p>
