Comments: Under the stationary equipment there is an accumulation of water/staff added water for water play. Standing water/wading pools are prohibited as they are unsafe and can be a breeding ground for insects, algae, bacteria. Water must be drained immediately. Only fresh water in water tables or running water such as sprinklers are permitted in the outdoor play area.

Comments: There is an inadequate amount of protective surfacing under the play structure. The ground seems compacted under the gravel and bare spots of earth are showing in high traffic fall zones. It is recommended that the operator ceases use of the structure until the surfacing is at an adequate depth to protect from a fall.								
Also, the plastic floor of the structure, located at the top of the slide, is soft and beginning to sag/buckle. Operator must have the structure inspected to ensure safety and if required, replace the equipment.
