Comments:	nments: During the monitoring inspection, the Quality Assurance Monitor observed some broken toys and some garbage in the outdoor play areas. The Quality Assurance Monitor reminded the administrator that the outdoor play area must be kept safe and free of hazards.

Comments: During the monitoring inspection, the Quality Assurance Monitor observed that the protective surfacing under the stationary equipment wasn't of an appropriate depth. The Quality Assurance Monitor informed the administrator that some wood chips must be added under the stationary equipment. The administrator explained to the Quality Assurance Monitor that the play area was not being used at the moment and they are waiting to get new stationary equipment and some wood chips would be added at the same time.

During the monitoring inspection, the Quality Assurance Monitor noticed that a child was sleeping directly on the floor of the classroom. The Quality Assurance Monitor asked the educator if the child normally sleeps directly on the floor or if a mat is provided to the child. The educator explained to the Quality Assurance Monitor that children in her classroom normally don't sleep, but some children have just moved up from the other classroom and are not quite used to not napping yet. The Quality Assurance Monitor reminded the educator that a mat must be provided for children who wish to nap.

Comments:	omments: During the monitoring inspection, the Quality Assurance Monitor observed 2 infants sleeping in their classroom with no educators present. The Quality Assurance Monitor asked the administrator who was the educator responsible for the 2 infants. The administrator explained that the door was left open and the educator in the connecting room was doing checks every 15 minutes. The Quality Assurance Monitor informed the administrator that the 15 minutes check only applies when infants are sleeping in a crib. The Quality Assurance Monitor reminded the administrator that they must always have an educator present in the classroom while children are napping. The administrator stayed in the classroom with the infants until the educator returned from her lunch break. Deficiency is now compliant.

Monitoring inspection was conducted. While on site the Quality Assurance Monitor verified if all necessary information was posted in a visible and prominent place in the facility. During the monitoring inspection the Quality Assurance Monitor observed some children napping, some children were doing TIE DIE shirt and the afterschool children went to play outside.
