The administrator told the inspector that everybody of the facility is going for their first aid certificate on March 21st.			
11(c)(ii) The qualifications and training requirements for administrators and educators are as follows: (c) at a full-time or part-time early learning and childcare centre, (ii) on and after July 1, 2020, (A) at least 50% of educators must hold a one-year Early Childhood Education Certificate or training that is equivalent in the opinion of the Minister, and (B) an administrator must hold a one-year Early Childhood Education Certificate or training that is equivalent in the opinion of the Minister.	11(c)(ii)	Sep 26, 2025	
Comments: The administrator and 2 educators out of 4 hold an Early Childhood Education certificate. The operator must ensure that 50% of educators hold an ECE certificate or the equivalent. The operator must submit a written plan to the Quality Assurance Monitor on how they will comply with this element.

The inspector informed the administrator that the educator can't be on the premises without a vulnerable sector check. The educator cannot return until the Department has received a copy of the completed check with a vulnerable sector. Later, the same day, the inspector received a copy of the check via email. Deficiency is now compliant.

Comments: The inspector observed in 1 out of 6 child files verified that the parent did not sign they have read and understood the parent handbook. The inspector received via email pictures that the information was added into the child file. Deficiency is now compliant.			
40(1) An operator of a licensed facility shall ensure that personal belongings of a child receiving services at the licensed facility that are brought to the licensed facility, including combs, brushes, toothbrushes, towels, washcloths, bedding, pacifiers and soothers, are (c) stored separately for each child.	40(1)(c)	Mar 10, 2025	
Comments: The blankets were stored in the cubbies. However, the sheets remained on the cots, and some potentially touching others. The inspector will verify with public health.

<p>Comments: While walking in the facility, the inspector observed 3 educators in group A. The administrator came at the facility not long after and gave ratio to the inspector. The inspector asked the educators how many children were in their care. Group A told the inspector she has 14 mixed age children with 3 educators and 1 educator with 10 mixed age children in group B. One educator from group A then moved to group B and the administrator joined Group A. The inspector informed the administrator that group A was over capacity as the regulation require a maximum of 2 educators per group. The administrator stated that she is not aware of this regulation, therefore the inspector discussed this regulation. While on site, the inspector gave recommendations on how to achieve compliance. To meet the requirements, one child from group A joined Group B. Deficiency is now compliant.</p>
