Comments: The inspector observed in 2 classrooms that the planification of daily activities is missing since October. The administrator must ensure that educators are planning daily activities, and they are documented.

Comments: The inspector observed a Febreze Air room spray bottle on a cabinet inside the washroom. The administrator must ensure that all toxic products are locked by a key. The administrator immediately locked the product. Deficiency is now compliant.			

General Comments
The inspector observed children playing freely both indoors and outdoors, as well as during lunch and nap time. Children were dancing and engaged.

General Comments

The facility is implementing learning stories as documentation, which is available for parents.

The administrator stated that they are currently revising the daily routine and that a copy must be posted in a prominent location inside the facility.
The administrator must ensure that all required information is completed in each child's file, including emergency contact addresses, confirmation that parents have read and understood the parent handbook, and the medical practitioner's address.

The inspector observed a gray plastic bin that is broken inside the playground. The inspector advised the administrator and stated that educators will remove it from the playground.

The staff-to-child ratio was respected during the inspection.
