During the inspection, the children were eating lunch. The Quality Assurance Monitor was also able to observe naptime.

Safe, quiet and secure environments are provided for rest periods that respect the child's individual needs. The administrator mentioned to the Quality Assurance Monitor that a new administrator will shortly be employed at the facility. The Quality Assurance Monitor reminded the administrator that an application for change must be submitted before changes are made. The application can be sent to the QAM when the time comes.

The QAM also noticed that the morning preschool service is no longer being offered at the facility. With that, an application for change must also be submitted, in order to remove the service.
