<p>General Comments</p> <p>The Operator has incorporated many more learning centres and provided many more materials for the children . The new shelving allows the children to have direct access and help them organize the materials when they are done playing. The Operator is using pictures, artwork, and individual binders to document the children's learning. There is a pre-planned program and the Operator's planning is reflective of the children's interests.</p> <p>Children were encouraged to eat but were not forced to finish if they said they were done. Licensing staff observed the children returning to the table with their lunch bags when they felt hungry, and this was not discouraged.</p> <p>Operator was engaged with children on their level and always put the children's needs first. Positive child guidance and a gentle approach was always used with the children.</p> <p>Some of the children's files are missing consents. Please have the children fill the consent forms out and forward them to me. Once this is complete, licensing staff can recommend facility for licensing.</p>
