The outdoor space has been extended into the wooded area offering a larger area for the children to explore and play in. There is a mud kitchen, large wooden blocks, a school bus, play structure, ride on toys and several trucks and materials for digging and scooping. The indoor play area also has many materials available for the children. This includes trucks, animals, a kitchen area, grocery store area, books, loose parts, musical instruments, puzzles, blocks and a wide variety of Art materials. The operator has also incorporated a quiet nook for the children where they can engage in quiet activities or just separate themselves from the busyness of the play area.

It is evident that the children have a good relationship with the Operator. They all call her Nan and were observed going to her for hugs or comfort when they were upset. The Operator's demeanor is gentle and kind. She redirects the children's more challenging behaviors and speaks to them at their level.

The Operator had daily documentation for the children and the children's learning was displayed by pictures with phrases and artwork that was created by them. The Operator stated that one of the curriculum consultants was going to come and guide her further in this area. Licensing staff will also refer Operator to the district team for further guidance.

Please ensure when using the daily logs for incidents that you have named "Boo Boo reports" are always being signed by the parents. I did observe the operator giving a midday update to the parent(s) via social media. The Operator did state that she also advises the parent(s) of any incidents that have occurred when they happen.

The Operator does have 6 hours of professional learning hours and will work on completing the next 4 hours by December 31st. I did explain to the Operator that we look at the 10 hours of professional learning within the licensing year which means for the next license renewal we would look at the professional hours between January 31, 2025 and December 31, 2025.

All documentation for licensing was organized and complete.
