A pre-planned program and the children's learning is being documented in several ways. Each educator was able to demonstrate learning in their classrooms. The operator is looking for ways to enhance the physical environment. The quiet area in the 2's room is a great addition.

Educators are following appropriate managing illness guidelines and completing potential illness forms as required when children must leave due to illness. A notice to inform parent(s) was placed on the door for review prior to entry.
