Comments: During my inspection, it was brought to my attention that only two staff members are working between 7:30 am and 8:00 am and that all children arriving between 7 am and 8 am are combined downstairs in the infant room. This means that the group is off ratio during that time and that infants are being mixed with other age groups to meet ratio. This was correlated with staff and children attendance records. Child-Staff ratio must be always maintained, and infants cannot be mixed with other age groups.

Comments: All staff members must have attendance records. This includes the staff member who does payroll and the Operator/Administrator. I was informed that no attendance records are kept for either of them.

Comments:	Upon my arrival, I did ratio in all classrooms. When I went downstairs to do ratio in the infant room, there was eight infants with three staff members. That said, one of the staff members, was the one who greeted us upstairs upon arrival and was doing payroll. Therefore, she was not intended to be the third staff member in that classroom that day. When asked who the third staff member should have been today, I was advised that it should have been the Operator/Administrator, but that she was out for an appointment until noon. This means there was eight infants with two staff members for an undetermined amount of time, putting them off ratio. The additional staff member was asked to remain in that classroom until the Operator/Administrator returned to the Centre at noon. Child-Staff ratio must be always maintained.
