When I arrived at the infant room, there was six infants with one educator and all infants were awake expect one was still sleeping. The other educator was in the bathroom changing a diaper with one infant. Therefore, there was a total of two educators with seven infants. The Staff-Child ratio for infant is one staff to three infants. The operator advised she is assigned to the infant room in the afternoon and only went to her car to get the Kleenex while the children were sleeping. A reminder, ratio can only be reduced by half when all children are sleeping, and ratio must be maintained in the building.

The outdoor emergency exit was shovelled.

The children celebrated valentine's day, there was cookies and cupcakes.
