General Comments

Every classroom has documented a pre-planned program; however, the 4-year-old room is not up to date. After speaking to an educator in the 4-year-old room, children are now going outside when needed vs. during designated times. A reminder that children must go outside a minimum of one hour per four-hour block, weather permitting. This means one hour in the morning, one hour in the afternoon.

This educator in the 4-year-old room this morning was not ware of any programming requirements for this classroom. The full-time staff member is planned to arrive between 9 and 9:30, however, did not arrive until 9:56 a.m. This means, this morning, the children did not have any programing or guided/pre-planned learning experiences other than free play.

Although the contact sheet was updated in the entrances, the Inspector Investigator's contact information is missing. Please add.

There are only nine children registered in the 2-year-old classroom. A reminder that only three children can be in the area near the door with one educator.

The milk bottle in the refrigerator was labelled with the child's name.

Three of the 2-year-old napping mats are ripped and need to be repaired. (no tape)

Parents must have permission to enter the centre, at any time. Therefore, the signs that is near the upstairs hallways, stopping parents from going into the classrooms, must be removed.
