General Comments

Licensing staff arrived at the licensed facility on March 7th, 2022 and was screened for Covid-19 by signing in at the centre upon entry.

The licensed facility was very clean and the educators were observed engaging with the children in all classrooms. Licensing staff heard lots of communication between educators and supervisors to ensure the first day of March break ran smoothly!

The children were all engaged in activities and lots of laughter and rich conversation was heard between other children and educators.

At the time of the licensing renewal inspection, it was noted that an educator who was 18 years of age was alone in a classroom with a group of children however, there were 2 supervisors in the building and were observed checking in with the educator multiple times during the inspection visit. Please ensure that an educator under the age of 19 years of age shall be supervised at all times when he or she is working directly with a child by an educator who is at least 19 years of age as per Regulation 9(2) of the Early Childhood Services Act.

While licensing staff was conducting the license renewal inspection, it was noted that the couch located in one of the classrooms was broken and the material is wearing off. Please ensure this piece of furniture is removed
