General Comments	
During the inspection I observed the children of this licence playing organized floor hockey. Other activities were accessible to them including: art supplies, dollhouses, and books, among other potential activities.	
The children were bussed to a nearby elementary school playground to play outdoors. They were all dressed appropriately for the weather. There was ample equipment available and space to play. Educators kept good sightlines during time at the playground and performed headcounts when boarding the bus again. Snack was available to the children after returning from the playground, before returning to indoor play.	
Educators verbally gave children advanced notice about upcoming transitions, such as transitioning to playing outside and coming back in. Educators actively engaged in conversations and play with children, both indoors and outdoors, throughout the inspection. Educators provided prompts and reminded children about guidelines in place for safety.	
All children's files observed were found to be complete and up to date. All necessary postings were observed and clearly visible.	_
