General Comments

Upon licensing staff arrival, children had not yet arrived from school. During this time, licensing staff reviewed staff and child files; all files were found to be compliant.

The Get Active buses later arrived with the groups of children from school. Upon arrival, children hung up their personal belongings, changed their outdoor footwear, and were observed washing their hands prior to snack time.

Due to a short, planned power outage that had been advised on the day of the visit, all groups remained in the main room until power was restored, as the lights in the gymnasiums and classrooms were temporarily unavailable. During this period, the administrator facilitated a trivia activity in which children played against an educator, answering trivia questions.

Once power was restored, an educator clapped their hands three times, and the children clapped in response, signaling it was time to clean up and prepare for activities within their respective groups. Educators directed children to wash their hands before entering the classrooms.

The younger group transitioned into the classroom, while the other group remained in the main area. In the classroom, children engaged in free play with magnetic blocks, large LEGO blocks, a small pool table, colouring materials, Barbie dolls, and board games. One group of children was observed playing "hand hockey" on mats.

The older group remained in the main area and participated in activities such as ping pong, pool, drawing, and foosball. The tables used for snack were cleaned, and educators were observed actively engaging and playing with the children.

Later in the afternoon, both groups transitioned to the gym/warehouse area, where children were able to run and play freely. Educators asked the children what they would like to play, supporting a child-led program approach. The children chose to play "wall ball."

Throughout the visit, only positive child guidance was observed. Fire drills are completed on a monthly basis.

General Comments

Licensing staff recommends the program for renewal.
