Suggest all staff use a planning tool, such as a web or notebook, to record their observations of the children as this would demonstrate purposeful planning using children's interests.

The operator is still waiting for the annual fire inspection, licence remains in continuation as this is outside of the operator's control. Once the fire inspection has been completed, Operator must send a copy to the QA Monitor.
