22 The daily routine of a licensed facility shall include (a) outdoor play for at least one hour in each four-hour block of time when the majority of children receiving services are in attendance except in the following circumstances: (i) the wind chill is below -20 °C; (ii) the temperature is below -20 °C; or (iii) the temperature is 33 °C with humidity or above.	22(a)	Feb 26, 2020	
Comments: During the renewal inspection the infant group did not go play outside. The educator mentioned that due to the warm temperature the infants would get wet and won't be able to enjoy the outdoor play area in the afternoon. As mentioned in the Operator manuel Outdoor play is important to a child's healthy development. All children, including infants, are expected to play outside each day. Outdoor play occurs daily for one hour in each every four hour block of time.

<p>Discussion during time of renewal inspection:</p> <ul style="list-style-type: none"> - A discussion in relations to the staff/child supervision for the infant playroom. Inspectors clarified the number of children allowed to play in each area. Inspector and the educators discussed the ratios for early morning when children arrive on site and the groupes are not full. Clarification was made with the educators in regards to the 15 minutes check during naptime. A log is being used however the time of the checks aren't being recorded or initialed. This must be done immediatly. Also clarification as to the ratios for infants that must be maintained at all time even during naptime. - Menu substitution need to be logged in the event of a change as to inform parents and be available for inspectors if needed. - Reminder that the vehicle registration is due at the end of the month (February 29th 2020)
