During the inspection, the administrator informed the inspector that the inspection was conducted the same day as the fire drill and documented the date of the inspection and signed the form. Deficiency is now compliant.

Comments: During the renewal inspection, the inspector observed that one educator is supervising a group of 5 children requiring 2 educators while the second educator brought children to the bathroom and performed diaper changes. To ensure that children are properly supervised at all times, the educator must bring all children under their supervision to the bathroom with them during diaper changes. During the inspection, a second educator returned to the classroom. Deficiency is now compliant.									
General Comments									
During the renewal inspection, the inspector observed snack time, indoor free play, lunch quiet time and outdoor free play. The inspector observed an educator reading a book to a group of children.									
The inspector had a discussion with the administrator in regard to having staff members use gentle reminders and positive reinforcements in order to encourage children to learn acceptable behaviors.									
During the inspection the ground is frozen; therefore, the park assessment will be conducted in the spring with a member of the licensing team. The use of the outdoor play structures is not recommended as the ground is frozen and does not provide protective surfacing.
