Comments: During the monitoring inspection, the Quality Assurance Monitor noticed that the Monthly Emergency Evacuation and Fire Drills were not completed for the month of July and had not yet been completed for the month of August. The Administrator has shared with the QAM a plan to be able to complete the July and August Emergency Evacuation and Fire Drills. Once the Administrator has provided documentation of their August and September Evacuation Drills, the non-compliance will be considered corrected. Emergency Evacuation and Fire Drills must be completed each month.

Comments: During the monitoring inspection, the Quality Assurance Monitor did a follow-up regarding the 10% shade requirement for the outdoor play space. The Administrator shared that because of their current application of change to add new structures to the playgrounds, the administrator thought that they could not use the play ground until the changes had been completed and approved. The children have instead been going on walks and have gone to the baseball field to play outdoors. Since they were not using the outdoor play space, they had not installed their new tarps. The Quality Assurance Monitor has confirmed that in their case with the types of changes they are making, the children are still able to use their outdoor play spaces as long as they do not use the structures until they are installed according to their safety requirements and that they have been inspected by the licensing team to ensure that they meet regulations. The Administrator shares that they will place the tarps on Monday. The children must have access to a surface of at least 10% of shade when playing outdoors in their outdoor play area.

The Quality Assurance Monitor is on site for a monitoring inspection. During the inspection, the Quality Assurance Monitor was able to observe the children during their snack time, during transition moments and during free play. During the inspection many groups went on neighborhood walks.

During the inspection, the Quality Assurance Monitor also did a follow-up with the administrator regarding the outdoor play structures that they are adding to their outdoor play space. The administrator shared that they are not ready to be used yet and that they are working on making sure to add the safety requirements needed for each structure. The Quality Assurance Monitor reminded the administrator that as soon as they are ready to use the structures, that they can contact their Quality Assurance Monitor to come do the change of service Page 1 of 2

The administrator also shared that they will be installing the outdoor tarps every monday and removing them every friday in order to make sure that they are not stolen over the weekend.

During the inspection, the Quality Assurance Monitor was able to observe educators who were engaged with the children. Positive Child Guidance was observed in all groups during the inspection.
