Administrator must ensure that children do not use the outdoor play area until it is approved by ELC licensing staff during the Change in Service inspection. Deficiency is now compliant</p>			
<p>31(3) An operator shall maintain the outdoor play area of a licensed facility to ensure the safety of the children.</p>	31(3)	Jun 23, 2022	
<p>Comments: During the Renewal Inspection on June 22nd 2022, inspector observed new modules that have been added to the outdoor play area as well as a large dirt pile. A discussion was had with the Administrator and the Corporation Director, who indicate that the outdoor play area is not currently being used by children due to current renovations. Before the children begin using the outdoor play area, Administrator must ensure that the correct protective surfacing has been placed around new play modules by verifying the manufacturing manuals and ensure that the space is maintained safe and free of hazards.</p> <p>Inspector will verify the outdoor play area during the Change in Service inspection to ensure that it is maintained safe and free of hazard.</p>			
<p>31(4) An operator shall ensure that the outdoor play area of a licensed facility (a) includes a shaded area that is at least 10% of the outdoor play area.</p>	31(4)(a)	Jun 23, 2022	
<p>Comments: During the Renewal Inspection on June 22nd 2022, Inspector observed that shades have not been placed in order to ensure that 10% of the outdoor play area is shaded throughout the day. A discussion was had with the Administrator and the Corporation Director, who indicate that the outdoor play area is not currently being used by children due to current renovations. Before the children begin using the outdoor play area, Administrator must ensure that the proper amount of shade is added.</p> <p>Inspector will verify the outdoor play area during the Change in Service inspection to ensure that the proper amount of shade has been added.</p>			
<p>48(2) An operator of a licensed facility may supply food to a child receiving services at the licensed facility that a parent or guardian of the child brings from the child's home if the food is labelled with the child's name and refrigerated, as required.</p>	48(2)	Jun 29, 2022	Jul 13, 2022
<p>Comments: All verified water bottles and lunch boxes were labelled with the respective child's name. Deficiency is now compliant</p>
