Comments: Inspector was unable to see programming of the daily activities for the school aged children. Administrator must ensure that programming for the school aged children is documented and made accessible to the Inspector.

Comments: Inspector observed that the paint on the walls is chipped in various classrooms. Inspector also observed that the floor is broken in certain classrooms as well as in the hallway. A discussion was had with the Operator regarding this, who indicates that they are aware and will begin painting and repairing the walls and floor where needed in order to ensure that the indoor play area remains safe and clean.

Comments: Inspector observed that there is not a distance of 46cm between 2 rest mats. This was addressed with the Educator and corrected immediately. Deficiency is now compliant			

General Comments

Inspector was unable to verify the protective surfacing for the stationary equipment, due to the snow. Educators and Operator confirm that the children do not use the stationary equipment with the house and slide during the winter, as there is no protective surfacing. This will be verified at a later date.

Operator must ensure that the diaper changing procedures are posted closer to where the diaper changing occurs, in order for the educators to have easier access to this information during the diaper changing.
