<b>General Comments</b>
<p>The staff are very attentive to the children. They were down at their level engaging in conversations, giving warnings for transitions, and reading and playing with them. The environment is calm and the children seem happy.</p> <p>The casual care program has not been open consistently throughout the year due to covid-19. The facilitator stated that a pre-planned program has been a struggle. The program is closing for the summer but I advised the facilitator and the administrator that the Quality Assurance Monitor would verify programming in the fall.</p> <p>The administrator has completed 7 months of a two year ECE program. An exemption request has been received and forwarded to the appropriate person for review. The number of educators with their ECE required in Casual Care will depend on how many children are in attendance.</p> <p>Facility has not been using a fenced in outdoor play space. Please ensure that both infants and preschoolers are using the fenced in areas to play that are age appropriate to them.</p> <p>The older infants were using a space next to the other infant area which is unclear whether or not it is approved</p>
