**General Comments**

Upon Licensing staff arrival for the renewal inspection, the infant children were outdoors playing, and the 2-year-old children were indoors finishing a morning activity.

The outdoor play space was fully fenced and secured with a gate latch. Play material was in good condition and Educators were spread out to ensure proper supervision. Before leaving the gated area to come indoors, a headcount was observed, and then the infants were placed in wagons to help ease the walk across the parking lot area. Once to the stairs, Educators lined up with the infants to come indoors. While entering with the infants, the 2-year-old children were observed walking together to the outdoor play space. Upon entry, personal belongings were hung up on hooks and proper diaper changing as well as handwashing procedures were observed.

The indoor play space was clean and organized. Several positive changes have been made with documentation of learning, planning, and child representation. Each room had current learning stories posted, family photos, children's artwork on display and there was evidence of purposeful planning. Play material in each classroom was in good condition and age appropriate. Throughout the morning, children were observed looking at their faces in mirrors, playing with wooden puzzles, playing with soft material and choosing books from easily accessible shelves. Educators were actively engaged with the children and were heard singing songs, offering snuggles, reading stories, and using positive words of encouragement.

During lunch, Educators were sitting with the children, and gentle reminders were heard in the 2-year-old room to stay seated while eating. Age-appropriate independence was observed when cleaning up lunch boxes and putting water bottles away. After the children finished eating, the floors were swept, and the tables / highchairs were cleaned. Proper handwashing as well as diaper changing procedures were again observed and the transition to nap time was smooth. Calm music was played in each classroom as well as the designated rest area for the infants.

During inspection, child and staff files were verified. Professional Development hours for the 2024-2025 licensing period were complete, and Educators are well on track for the 2025-2026 licensing period. Monthly fire drills, outdoor maintenance checks and daily attendance forms were completed. Daily information is being

recorded, and the parent board was organized. As a reminder, please ensure that mop buckets are emptied after each use and not stored with water.
